NOTIFICATION

As recommended by the 6th meeting of Research Council held on 11.12.2017, the 113th Meeting of the Academic Council, Dibrugarh University held on 12.12.2017 vide Resolution No. (10) approved the following amendments in the Dibrugarh University Regulations for the Research Council and for the Degree of the Ph.D., 2016 (amended upto date) giving effect from the academic session 2016-2017.

Clause	Existing provision	Amended Provision
9 (a) (ii)	A Faculty member of the Post Graduate Departments of the affiliated Colleges of the University with adequate research infrastructure (to be ascertained by the Research Council) and a minimum of 1 (one) year teaching experience having at least three research papers published in the referred journals. Out of these, one paper must be published after attaining the Ph.D. Degree and shall have to be the corresponding author. However, in case of not fulfilling the conditions above, proportionate weightage shall be given as per UGC norms.	A Faculty member of the Post Graduate Departments of the affiliated Colleges of the University with adequate research infrastructure (to be ascertained by the Research Council) and a minimum of 1 (one) year teaching experience having at least three research papers published in the referred journals. Out of these, one paper must be published after attaining the Ph.D. Degree and shall have to be the corresponding author. However, in case of not fulfilling the conditions above, proportionate weightage shall be given as per UGC norms. Further, the recognition of the Ph.D Supervisorship to a faculty member of an affiliated College/(Institute) is attached with the institutional recognition of the College/Institute where he/she works, and hence the change of the College/Institute shall lead to the cancellation of the Ph.D Supervisorship of the person concerned.
9 (d)	The faculty members of other Universities/ Institutions of repute may also be recognized as the Co-supervisor under special circumstances on recommendation of the DRC concerned. In case of the prospective research supervisors from the Institutes of repute, with whom the University does not have an academic collaboration, the prospective supervisor shall have to submit a No Objection Certificate from his/ her own Institute issued by the competent authorities. Apart from the above he/she shall have to comply with the eligibility criteria as prescribed in clause 9(b).	The faculty members of other Universities/ Institutions of repute may also be recognized as the Co-supervisor under special circumstances on recommendation of the DRC concerned. In case of the prospective research supervisors from the Institutes of repute, with whom the University does not have an academic collaboration, the prospective supervisor shall have to submit a No Objection Certificate from his/ her own Institute issued by the competent authorities. Apart from the above he/she shall have to comply with the eligibility criteria as prescribed in clause 9(b). Provided that the recognition of Ph.D. Supervisorship to the person from other institutions on the basis of the NOC shall be considered subjectively by the School Board concerned.
