**NOTIFICATION**

As recommended by the 114<sup>th</sup> Meeting of the Under Graduate Board held on 17.05.2016 the 107<sup>th</sup> Meeting of the Academic Council held on 31.05.2016 approved the partial modification in the relevant clauses of the Dibrugarh University Regulations for the Bachelor of Computer Application (BCA) Programme and Dibrugarh University Regulations for the Three Year Bachelor of Business Administration (BBA) Programme in the Semester System, 2008 (as amended up to date) in order to accommodate the following provision:

*A candidate who fails or does not appear in one or more papers of any End Semester Examination up to the Sixth Semester will be provisionally promoted to the next higher Semester with the failed paper(s) as carry over paper(s). Such candidates will be eligible to appear in the carry over (backlog) papers(s) in the next regular examinations of those papers.*

*However, a student must clear all his/her semester examinations within Six (6) years from the date of admission to the First Semester, irrespective of the number of examinations appeared by the student, viz. 1<sup>st</sup> and 2<sup>nd</sup> Semester Examinations shall have to be cleared in 6 consecutive chances, 3<sup>rd</sup> and 4<sup>th</sup> Semester Examinations shall have to be cleared in 5 consecutive chances, 5<sup>th</sup> and 6<sup>th</sup> Semester Examinations shall have to be cleared in 4 consecutive chances.*

*If a candidate clears the Sixth Semester Examination before clearing all the papers of the previous semesters, the result of the Sixth Semester Examination of that candidate shall be kept withheld and his/ her results shall be announced only after he/ she clears the papers of the previous semesters.*

The above modification shall come into force with immediate effect. Further, this notification supersedes all existing provisions regarding the number of legitimate chances to clear the End Semester Examinations of the BBA and BCA Programmes.
