The 106th Emergent Meeting of the ouncil, Dibrugarh University held on 26.05.2015 vide Resolution No. (02) has approved modification in clause 11 of the Dibrugarh University Regulations for the B.A./ B.Sc./B.Com Programmes in the Semester System, 2010 as below:

Clause(s)	Modified as-
11(d)	<ul> <li>(i) A candidate who fails or does not appear in one or more courses of any end semester examinations up to Sixth Semester shall be provisionally promoted to the next higher semester with the failed course(s) as carry over course(s). Such candidates will be eligible to appear in the carry over course(s) in the next regular examinations of those courses.</li> <li>(ii) If a candidate clears the sixth semester examination before clearing all the courses of the previous semesters, the result of the sixth semester examination of that candidate shall be kept withheld and his/her results shall be announced only after he/she clears the courses of the previous semesters.</li> </ul>
11(e)	A student must clear all his/her semester examinations within Six (6) years from the data admission to the First Semester of an programme irrespective of the number of examinations appeared by the student, viz. Is and 2 <sup>th</sup> Semester Examinations shall have to be cleared in 6 consecutive chances; 3 <sup>rd</sup> and 4 <sup>th</sup> Semester Examination shall have to be cleared in 5 consecutive chances, 5 <sup>th</sup> and 6 <sup>th</sup> Semeste Examinations shall have to be cleared in 4 consecutive chances.

The above modifications shall come into force w.e.f. the academic session 2011-2012
